#### SCHEDULE

Meet at the Cove Picnic Area inside Lake Chabot Regional Park  
(east side of lake, opposite from the marina)

Registration (**SAME DAY ONLY**): 8:00 – 9:30 am

Course Walk: 9:00 am

Sub-Bantam Race 2000 meters: 10:00 am (first race)

Bantam & Midget Races 3000 meters (to be run separately)

Youth 4000 (Intermediate & Young Will Run 4000 with Youth)

All races end at the Cove Picnic Area

Note genders may be combined, depending on number of runners.

**From 580 W:** Exit 32 for 150<sup>th</sup> toward Fairmont Drive, merge onto Freedom Ave, left onto Fairmont Drive, Fairmont becomes Lake Chabot Road; entrance is on your left once you are over the hill .2 miles.

**From 580 E:** Exit 35 for Strobridge Ave, right onto Stanton Ave, right onto Castro Valley Blvd, left onto Lake Chabot Road, look for entrance on your right 1.8 miles down the road.

Race is on "roller coaster-like" paved bike trail known as East Shore Trail.
