## CertChair Report

The 2014 USATF National Track & Field Championship (for OPEN athletes) Meet will be held in Sacramento from Wednesday, June 26 thru Sunday, June 29, 2014. Since the championship meet will be held in the Pacific Association, I, as the Certification Chair for Pacific Association Officials, was part of the Selection Committee for officials to work this meet. Each year, as a part of the selection process, I receive the names/events of all Pacific Association officials who applied to work a national meet. I gather together a number of experienced officials and we "evaluate" those officials. **This year, we observed that a number of officials applied to work a national meet in certifications that they do not yet have on their cards.** This isn't to say that the officials are not working these events, just that the "certifications" are not on their cards. ***Let us make this the year we get all of your cards up to date.***

### ***Some thoughts:***

- Each class will cost \$20.00. "Intro" classes will receive one (1) rule book as appropriate. "Introduction to Track & Field Officiating" students will have a choice of which rule book they want. LDR and Race Walking Intro classes will receive a USATF Rule Book after it is printed in February.
- **Clinic fees will be paid for at clinic registration at the beginning of the day.**
- This E-mail is to inform you of the classes and times of the clinics.
- Within 24 hours of this e-mail, you will receive a "targeted" E-mail which has a Google document URL. Use this URL to sign up for the class.
- When the clinic instructor has a handout, these handouts will go to those who signed-up in advance. If the instructor runs out of handouts you will not receive one during class but will receive an E-mail copy after class. **An "on-time" sign-up occurs a week before the clinic.**

### ***Let's get on with some UpGrading and adding to your certifications:***

- For our **27 APPRENTICE LEVEL officials certified in 2012**...IF you have a resume showing you have worked some 20<sup>±</sup> meets...this would be a good time to UpGrade your certification to ASSOCIATION LEVEL.
  - ✓ For our **69 APPRENTICE LEVEL officials certified in 2013**...you will need to take one or more of the Fundamental Classes before you UpGrade. This would be a good year to begin taking additional classes. If you have worked 20<sup>±</sup> meets, we could give consideration to your being UpGraded this year.

In order to UpGrade from APPRENTICE LEVEL to ASSOCIATION LEVEL, you need to take the appropriate **Fundamentals Class**. We offer three:

- 1) **Fundamentals in Throws/Horizontal Jumps**,
- 2) **Fundamentals in Vertical Jumps** and
- 3) **Fundamentals of Track Event Officiating** (with half the time devoted to Clerking and the other half devoted to Umpiring and Lap Counting...for Umpiring/Lap Counting to be complete, mentored practice is required).

- We have **104 ASSOCIATION LEVEL officials**. Surely some of you have worked an additional 25<sup>±</sup> meets as an ASSOCIATION LEVEL official and are now ready to be UpGraded to NATIONAL LEVEL. Do you have your resume? Have you taken the appropriate **Fundamentals Class**? Have you taken the appropriate **Advanced Class(es)**? We offer the following Advanced Classes: **1) Horizontal Jumps**, **2) Vertical Jumps** and **3) Throws**

Here is what the USATF National Officials Committee says about UpGrading in their *Rules, Regulations, And Procedures For Certifying Competition Officials*

When discussing the quality of the meets worked as an Association Level Official...At least two (2) of those meets must be either outside the official's local Association *or be Regional, National or International meets.*

Have a least two (2) positive, written recommendations *from two (2) different officials (one from each)* they have worked with or under. One recommendation must be from a Master-level official and the other may be from a National or Master-level official.

- We have **39 NATIONAL LEVEL officials**. Surely some of you have worked an additional 30<sup>±</sup> meets as a NATIONAL LEVEL officials and are now ready to be UpGraded to MASTER LEVEL. Do you have your resume? Have you taken the appropriate **Fundamentals Class**? Have you taken the appropriate **Advanced Classes**? Do you have the breadth of experience?

Here is what the USATF National Officials Committee says about UpGrading in their *Rules, Regulations, And Procedures For Certifying Competition Officials*

When discussing the quality of the meets worked as an NATIONAL LEVEL OFFICIAL... At least two (2) of those meets must be *must be Regional, National or International meets. Two (2) other meets must be either outside the official's local Association or be Regional, National or International meets. Officials seeking an upgrade to Master level are encouraged to seek out the highest level of meets in satisfying this requirement.*

- There is no cost for you to attend,
