- Coaches Committee Report from Jerry Colman via Dave Shrock: Run for the Dream Clinic Jan. 13, 14 & 17 was highly successful with 92 attending.; Al Hernandez is recruiting.
- Media from Fred Baer: 6,000 attendees at the Fresno meet; excellent local coverage
- Masters T&F from Joy Margerum: PA Championship at CSUS in July; PA will be doing the T&F/race walk events at the Bay Area Senior Games at Stanford 3-11/12. Ties into the National Senior Games coming there is 2009 (8/11-15).
- Athletes from Stephanie Brown: will be working with travel funds, grants, press releases; can put grant forms on PA web site; Fred Baer welcomed athletes to weekly media luncheons.
- Awards send Tom Moore nominees to Dan Davidson.
- LDR from Tyler Abbott: 4 athletes to receive travel funds for Winter XC Nationals; Headlands 50K awarded National Trail 50K Championship for 2006 and 2007; LDR 2005 Awards Banquet set for Feb. 11.

#### NEW BUSINESS

- Al Hernandez noted that USATF has grants for minority women coaches.
