MINUTES of September 20, 2006 Meeting

- **Approved** unanimously following one correction regarding sanctions: "Need to be submitted no later than 30 days before the event."

TREASURER'S REPORT

- **Approved** unanimously
- Tyler Abbott is requesting each committee to send him 1 or 2 budget priorities along with the accomplishments of several individuals for him to highlight in his donation request letters. He also need your committee email lists.

BACKGROUND CHECKS

- Due to Dept. of Justice delays in processing requests, the PA coaches will have to have checks performed at regional police departments.
- 1) Must be a PA member, 2) PA Office will send you the scan form; 3) get the scan; 4) then send for reimbursement.
- Check includes CA and national.
- No exemption for people previously checked for a different organization.
- Needs to be done on anyone who works with youth in a private setting.
- Enforcement: practices and meets will be observed for violations; there must also be some self-policing by individual clubs.
- Notices with the background check protocol will go out with club renewal notices. No club will be accepted or can get practice insurance until the checks are done.
- Offenses that the PA is looking for are posted at www.usatf.org.
- George Paddeck and John Mansoor are to receive the background check data.

2007 BOARD MEETING DATES

- Construction will stop during the meet.

- Open T&F Men and Women: PA Championships and the Grand Prix ready for 2007.
- Athletes: Pole Vault facility for poste collegiate athletes being developed with support of Tiger Bar Sports
- Race Walk: Grand Prix was over October 16. Louise Walters a top competitor.
- Youth: Largest turnout ever at PA XC Championships; sub bantams had their own race. 2007 T&F schedule is posted. Maria Casillas is the new Youth Officials Chair. Annual meeting held in October and the data system was established. Asilomar seminar has 30 –40 people signed up to date – has something for everyone! Possibility of National Youth Championships on July 4, 2009 although facility issues need to be resolved (?Folsom, ?Stanford)

- Dave Shrock submitted written coaches report. Reminded everyone of upcoming clinics: Distance Summit, Logan, CIF. \$2000 grant from USATF for increasing number of PA member coaches approved. Reno: will have a new track by 2008. Track to be developed around soccer field at Skyline College.
