- 50-year anniversary in 2009; need to create a new program
- Jarvis & Jack Sheppard plan to publish comprehensive book of results so at this time their data isn't available for sharing

2009-10-11 U.S. Outdoor T&F Junior & Open Championship

- If PA granted the 2010 bid will run on back-to-back weeks with 2010 Masters Meet
- 2011 off the bid list due to World Masters Meet

2009 Junior Olympic Cross Country National Championships

- Site visit in Reno went well; national committee all but guaranteed PA will receive the bid
 - Meet will be held at Rancho San Rafael Park; however, course will be reconfigured into more spectator friendly loops
 - o PA bid is partnered with UNR, local hotels, local tourism
- Long Beach is bidding against us
- John Mansoor stressed that in the next session at the Convention that Joanne Slaton-Camargo needs to introduce the PA committee who will in turn do the presentation

2010 U.S. Masters T&F Championship

CSUS will be the location for the meet

2010 Junior Olympic National T&F Championship

Won't bid if we get the US Masters Meet or USA Outdoor Open & Junior Meet

2011 World Master's T&F Championship

• Working on budgeting and planning

2010-12 - CIF State Cross Country Championship

• CIF doesn't want to go back to Fresno for the HS State T&F meet in future years

- Bidding for future meets: January June
- Currently seeking proper venue; two possible options located in our area
 - o Folsom Regional Park (plenty of land)
 - o Granite Regional Park (located across the freeway from Sac State; park is below sea level so at risk of flooding)
 - o Seeking a XC course that all levels of XC races can be contested
- Side Note: NCAA XC live on TV this week

Committee Reports

- LDR
 - No new update
- Membership
 - Already 938 PA members registered for 2008
 - 551 LDR
 - 90 Coaches
 - 102 Officials
 - 250 Youth
 - o Finished year (Sept 1 date) with 5,736 members
- Athletes
 - Reviewed grant proposal
 - ACTION: Stephanie Brown-Trafton
 - Remove requirement for college graduation
 - List all sanctioned event on application
 - Change application from must compete in 1 or more PA sanctioned meets to must compete in 1 or more meets in the PA area
 - Ensure website T&F schedule clearly denotes which meets are sanctioned
 - Add statement requirement that income level doesn't include spouses income
 - Add stipulation in contract that athlete competed in designated meet and will pay \$ back if contract not fulfilled
 - Add field for PA/USATF number
 - Reword drugging allegations statement; consider removing phrase
 - Submit final version of application via e-mail to Executive Board; e-mail can be given via e-mail
 - o Final vote needs to be completed by December 15
 - Communication: Promote availability of grant via PA website & e-mail to athlete distribution list
 - ACTION: Bruce Colman
 - Modify Officials calendar to clearly denote which meets are sanctioned by PA/USATF
 - **ACTION**: Recipient of award
 - Deadline to apply for grant is February 15, 2008

- After season, write story for CTRN & website sharing impact of grant
- **ACTION**: Create Selection Committee
 - Lead: Jerry Colman
 - Other Members: Fred Baer, Dave Shrock, Bob Podkaminer; possibly also Margaret Sheehan

Coaches

- CSU Stanislaus just hired 2 new coaches; building new facility just north of current
- o Offering a Youth Coaches school (6-hours long; free)
- o Side note: USA Olympic team will be staying North of Japan and flying in each day to compete due to the bad air pollution in Beijing, China

• Youth

- o PA/JO XC meet went well; youth competitor numbers are up
- o Ten percent of competitors at the USATF JO XC meet come from PA/USATF

Disabled

- IWAS is negotiating to purchase his home-grown software to be used worldwide to manage multi-sport competition registrations; will be donated by Charlie to organization to be used as a fund-raiser
- Continue to encourage everyone to incorporate disabled athletes into their events; especially in light of the many returning Vets who are now amputees or in wheelchairs
 - Para Olympics is gearing up to support these athletes as it is seen as a morale booster for the Vets

New Business

- National USATF office gave PA \$500 in credit to purchase merchandise; John purchased a variety of banners and flags that everyone is encouraged to utilize for your sanctioned events
- Dick Connors is coordinating an NCAA Division 1 collegiate coaches meeting focused on bringing the coaches together to discuss how to set up their schedules so that key, large invitationals aren't scheduled on top of each other
 - MOTION Approved: Request \$500 to cover cost of continental breakfast for coaches and airfare to the meeting for Dick. Meeting will be held in Northridge and focused on the 2008 T&F schedule; meeting is open to NCAA D2 and Community College coaches as well

- Dick Connors proposed a motion to approve the payment of stipends for all PA designated delegates attending the 2007 USATF Convention
 - MOTION Failed: due to need to keep processes in place and not to continue circumventing funding models
