Meeting called to order at 7:35 pm.

Request changes to minutes from last meeting

One change: George Kleeman was present in the meeting

Treasurer's Report-2008 Budget

Lloyd reviewed the proposed budget and opened up the meeting to discussion.

- John Mansoor shared that due to the drunken float incident last year PA/USATF may not insure Bay to Breakers this year
- [John Mansoor will](#) charge Nike events full price
- Athlete's Chair, Stephanie, added a line item for \$7,500 to fund training / travel expenses for athletes going to the 2008 trials. Funding would provide five \$1,000 grants and five \$500 grants. To qualify for the grant an aspiring athlete had to be a member of PA/USATF prior to today's meeting
 - Motion passed to approve this additional expense to 2008 budget
 - **ACTION:** Next BOA meeting Stephanie to have defined the criteria for qualifying for the grant process and the application process
- Pod requested a change to the policy regarding who can receive funding if they go to the national USATF convention. His proposal was to increase funding to cover all delegates and not just committee reps. At this time 12 of the 15 available delegate slots receive \$500; the remainder do not
 - It was agreed that this topic would be carried to the next meeting and discussed as new business
 - NOTE: Want to ensure that the wording for the amendment to the policy doesn't provide a headcount that can change from year to year but instead to state, "all delegates"
 - NOTE: Delegates can only be funded one way ... either through their Association or through the national USATF office
 - **ACTION:** Pod to place this issue on the next BOA agenda

- Cynci requested line item approval for the \$2500 already earmarked in the strategic plan for the remainder of the fiscal year to ensure media coverage of our fall 2007 cross country season.
- **ACTION:** Motion approved to spend \$2500 for the remainder of the year
- A proposal is in the works on how to spend the \$15,000 for 2008 that is in the budget. More details will be forthcoming in the next BOA meeting
 - Motion approved
 - **ACTION:** Cynci to return to next BOA with a breakdown how the money will be spent
- Budget and Profit & Loss statement
 - Ratified and approved by BOA

2009 Junior Olympic Cross Country Bid

Reno Tahoe Athletics is leading the bid process. Jim Vanden Huevell is the PA/USATF lead for the bid.

2009-2010 USA Track & Field Bid

Within the next 30-days expect to know who wins. Unknown at this time who else might be bidding for this event.

2011 WMA

Big push at the Italy based meeting for Brazil to win. Brazil was the first to present their bid followed by Joy representing PA/USATF. The PA/USATF bid focused on the athlete, the long-term success of PA/USATF to put on quality, high-level meets; transportation between venues and translation services. PA/USATF won the bid! The meet will be held at four venues in the Sacramento area (Sac State, Sac City, Folsom HS and ARC). One track will be used for warm-ups and the other three for competition. The meet will run for 10 days. At this time George Kleeman will be Meet Director. The meet will include a 2-day cross country championship, [Marathon](#) and a race walk road race. It is highly likely that by winning this bid that PA/USATF will also be awarded the 2010 US Masters T&F meet.

2007-2008 Golden West meet / PAC

Originally the plan was to hold the youth Sub-Bantam Championships the same weekend as the Golden West meet and then send several older kids to the Golden West to compete in running events. Unfortunately it turned out that National had to shift the youth T&F schedule to accommodate the Youth Outdoor T&F Championships in North Carolina June 24-29. Consequently the PAC meet was moved to the same weekend as GWI and will be held in a neighboring town. The PAC meet will attempt to leverage Folsom HS (GWI location) to host the hammer throw event on Friday evening [or Sunday morning](#).
