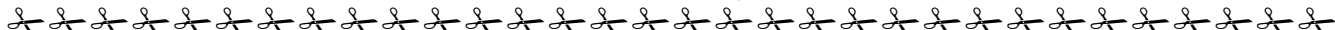
Special age-graded awards for walkers. **Art medals** for race walkers 1st through 3rd in each age group of 5-year increments.
