# BACKGROUND CHECK REPORT BY GEORGE PADDECK

- 359 checks done in 2007 (all PA members)

- To date only 147 have renewed their PA memberships for 2008; cannot receive info on nonmembers due to confidentiality laws.
- Motion unanimously approved that April 1, 2008 will be the termination date for any nonrenewed member's background check.
  - After this date if a member renews and requires a background check, that person will be have to get a new background check at their own expense.

## USATF NATIONAL T&F MEETS/CRAIG MASBACK/NIKE

- Extensive discussion concerning the legitimacy of the awarding of the 2008, 2012 Olympic T&F Trials and national open T&F Championships to Eugene, OR, with Craig Masback's resignation from USATF shortly thereafter.
  - Was the correct bidding process followed?
  - Were there any conflicts of interest?
- Unanimously approved that the Pacific Association send USATF a "letter of intent to file a grievance."
- Additional BOA input
  - · Conflict of interest clause
  - Seek diclosure
  - Bidding procedure
  - Did the Oregon USATF Association sign off on the bid?
  - National Athletes' Committee Chair and committee members not represented
  - Wheelchair athletes not represented
  - Seek a new operating procedure that prevents USATF employees from becoming employed by a potential conflict of interest company for 2 years.
