TIME: 8:30 a.m. (Number pickup and race day registration from 7:30 a.m. to 8:00 a.m.)
PLACE: Martin Luther King Jr. Regional Shoreline, Oakland, California (Arrowhead Marsh)
COURSE: Certified 2.5 km loop; Youth 1500m is 875 meters out and back.
ENTRY FEE: Pre-registration: \$20 for 20Km; \$15 for Open 10 & 5Km; \$5 for Youth 1500m. **Postmarked by August 29.**
Race Day: \$25 for 20Km, \$15 for Open 5Km, \$10 for Youth 1500m. **Please make checks payable to Laura Cribbins**
ELIGIBILITY: This is a judged race; all are welcome, but only USATF members are eligible for 20K Championship awards and only PA/USATF registered athletes are eligible for PA awards and Grand Prix Points. Awards to top three men and women in 20Km. (PAUSATF registration available online at www.pausatf.org.)
Note: PA/USATF registration is NOT required for Open 10 Km 5Km and Youth 1500m awards.
DIVISIONS: M/F 60+, 50-59, 40-49, 20-39, 16-19, 13-15, 12 & under. (GGRW Awards only.)
