Prior to the meeting the new USATF CEO, Doug Logan, joined our group in a face-to-face open dialogue.

High level comments made by Doug:

- USATF doesn't have a business mode; not structured same as other sports
 - o Need regular episodic events leading to a crescendo
 - o Something that you want to take your kids to watch
 - A season that starts X and ends X; includes annually repeating meets that are televised
 - o In today's world our sport offers a series of one-offs
 - o ACTION: In discussion with NBC to do a relay series weekend
- USATF has a governance system that defies comprehension; need tools at out disposal to move USATF to the 21st century
 - We are competing for attention of American public
 - o Selling ourselves too short; we set the bar too low
 - o Need to move sport to where it belongs ... where it once was
- Beijing 2008
 - USA didn't create environment for peak performance at Olympics
 - We failed because we did not create correct environment
 - o ACTION: Putting together a panel to figure out why US couldn't reach peak performance at the Olympics

Here are some of the key questions asked and his responses.

- Q1. Reorg is supposed to be voted on but difficult to do when no one can review documents
- A1. UOC is requiring reorg. Requires massive bylaw changes. LL committee told to draft changes.
 - Examples of concerns:
 - o Minutes for last four years can't be found
 - October 17 & 18 the LL will be presenting new bylaws; at end of 18th Board will adopt bylaws then present to general population for review at national convention in Reno in December 2008
 - o If changes are not accepted by membership and USOC then decisions will be made, possible decertification, loss of funds
- Q2. Media slashing reporter jobs ... makes it difficult to get the word out about our sport. How should we respond?
- A2. USATF needs to create content that can be printed "as is" in newspapers. Web needs to be primary location for content
- Q3. Our sport is a smorgasbord; how do you meld it all together?
- A3. We do offer a wide variety of disciplines. Let's build community ... become the connective tissue
- Q4. Undue influence of sports chairs on committee choices.
- A4. Issues in committee systems must be addressed and changed.
- Q5. What influence do athletes in soccer have over policy and bylaws?
- A5. Athletes are team oriented; had a union; under contract to organization they play with. He encouraged athlete interrelationships. T&F athletes are all independent entities. PAA could potentially be doing more ... part of restructuring is to encourage PAA to be on its own and not part of USATF
- Q6. What happened to the Olympic Festivals?
- A6. Didn't have continued leadership to run every 4 years. We don't have enough American based, high level competition locally, athletes keep going to Europe to compete instead of staying in the US

Next the meeting transitioned to a political positioning statement by Bob Bowman promoting himself for the next USATF president.

- PA Executive Board met with Doug Logan prior to BOA meeting. PA still waiting for documents to be provided by University of Oregon; based on findings after reviewing the documents will determine PA next steps

2009 JO Cross Country Nationals

 Nevada Commission on Sports changed focus after Jim Vanden-Huevel passed away this passed spring

- Now no one in the Commission wants to actively step up to run event as meet director
 - o PA will step in and fulfill meet director role
- Roland Martin (retired lawyer) will take on local leadership for event
- UNR considering taking on assistant role but possible conflict (college dead week with regard to HS athletes); may do course work
- October 7 PA meeting in Reno with key parties to determine who will be responsible for what attribute to host the event

2010 JO Track & Field Nationals Bid

- Youth requested that PA actively bid for this event
- Want to utilize Sac State for the venue
- Master's meet is week prior to JOs has already won the bid and will be held at Sac State (5-day meet) ... one rest day before JOs begin
- JO meet is a 6-day meet
- Goal is to set up venue once and use twice (Masters & Youth)
- Competing against Spokane and Boise for bid
- Partnership with Sac Sports Commission

- Coming along well
- Considering combining the Open and Master's meet into one
 - o **ACTION**: Joy, Al, Fred to report in November meeting outcome
