- **From Reno:** Merge onto I-80 W toward Sacramento (Entering California) Take the exit onto CA-99 S/I-5 S toward Sacramento/Los Angeles Continue to follow I-5 S Take exit 477 for Benjamin Holt Drive Turn right at W Benjamin Holt Drive Turn left at Cumberland Place Go a few blocks and park will be on your left.

- **From San Francisco:** Merge onto I-80 E toward Bay Bridge/Oakland. Take the exit onto I-580 E toward CA-24/Downtown Oakland/Hayward-Stockton. Continue straight onto I-205 E (signs for Tracy/I-205/Stockton) Take the exit onto I-5 N Take exit 477 for Benjamin Holt Drive Turn left at W Benjamin Holt Drive Turn left at Cumberland Place Go a few blocks and park will be on your left.
