By Law Proposal Amendment presented by George Kleeman

- (18) Representatives of athlete members, elected by their /respective Sports Committees at their annual meeting on the basis of one member for each eight hundred (or fraction thereof) athlete members as registered on June 30th, each year. Where athletes are members of or represented by more than one sports committee, each such committee will be entitled to count them in their athlete membership as a whole athlete, e.g. Joe Brady is both a racewalk athlete and a masters' thrower, At least one or 10% of the elected athletes, which ever is higher, must unattached. If there are not any unattached athletes available and willing to serve then an attached athlete may fill the position. NOTE: Attached athletes are represented by sections 16 and 17 of this article.
- Motion made by Dan Davidson to accept the proposal; seconded by Becky Klein; passed with 16 ayes; no nays.
