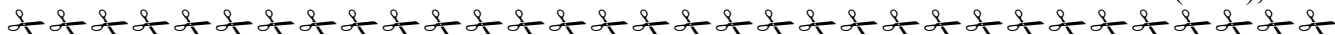
- RACE DAY REGISTRATION ON SITE, 6:30 AM to 7:00 AM (women) or 7:55 AM. (men)

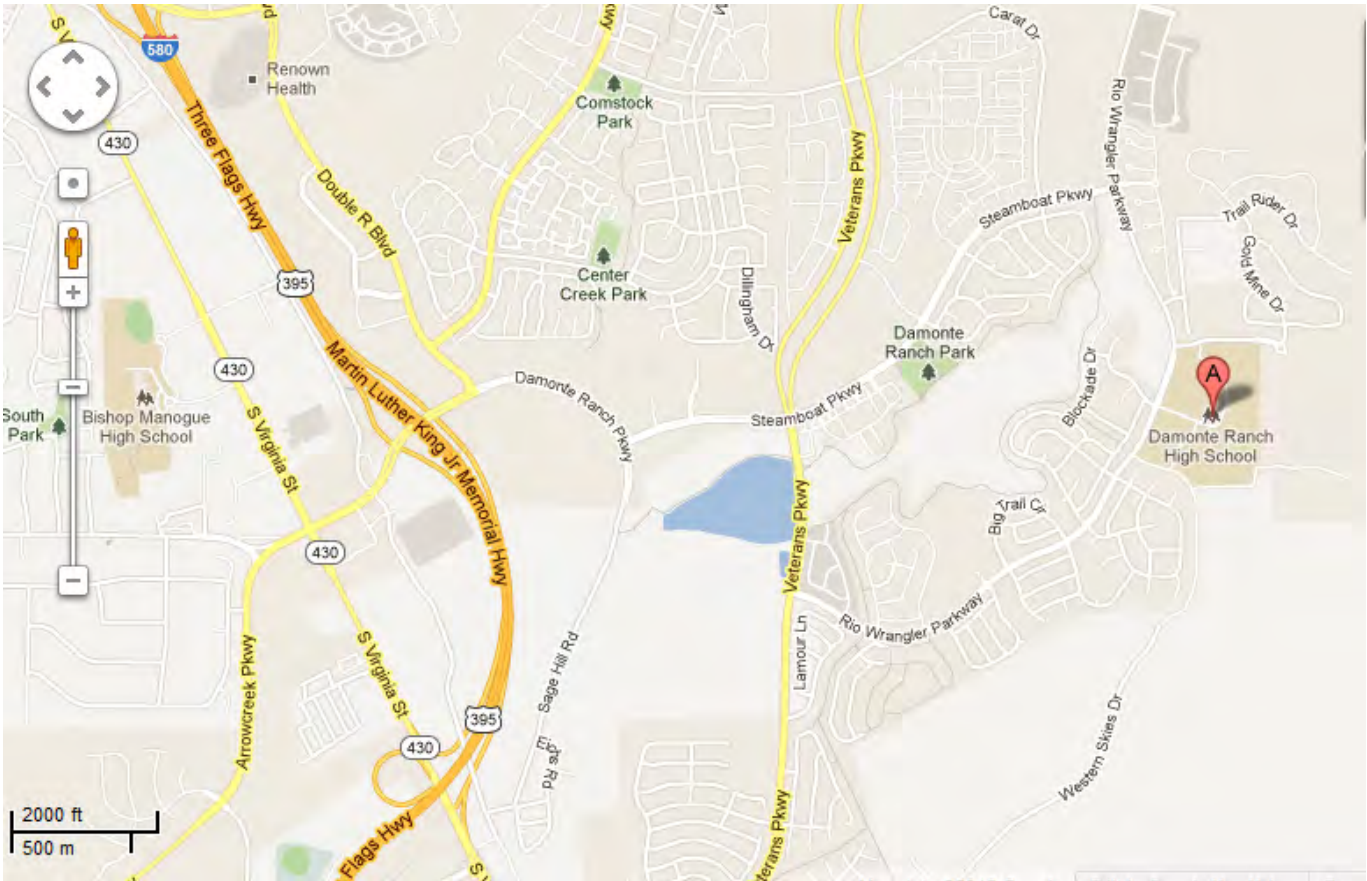
