- Races:** 20K USATF Western Region and Pacific Association Grand Prix Championships
Plus a 5K non-championship race
- Time:** **8 AM** (Packet pickup and race-day registration from 7:00 – 7:45 AM)
- Place:** **William Pond Recreation Area, Sacramento, CA**
- Directions:** From Highway 50, take the Watt Ave North exit. After about 1.1 miles turn right onto Fair Oaks Blvd. After about 2.4 miles, turn right on Arden Way, which ends at the park. Turn right, pay entry fee at the kiosk, and proceed to the last parking lot.
- Awards:** **20K: Western Region Championship Medals for the top 3, male & female,**
in each five-year age group.
20K Pacific Association Medals for the top three, male & female.
Pacific Association Grand Prix points.
5K: Ribbons for top three male and female.
- Eligibility:** All race walkers of any age. Awards only to USATF members.
- Post-race Awards & Picnic at the Park. Grilled stuff and potluck.**

- Entry fee:** **\$45** if postmarked by October 20. **\$50** after October 20 and on race day.
