Future Championships Report

John Mansoor, Executive Director (pausatf@aol.com)

1. University of Nevada-Reno is close to getting a University of Washington-type indoor track approved
2. Portland (Nike) was awarded the 2016 World Indoor Track Championship. They will have a permanent indoor track as a legacy. This means they will bid for Indoor National Championships.
3. Sacramento is one of two finalists for the NCAA Track Championships for 2015-18. Eugene is the other finalist. With Portland getting World Indoors in 2016 and Eugene doing Trials in 2016 Sacramento has a pretty good chance of getting NCAA Championship in 2016.
4. Sacramento is likely to also bid for 2016 Junior Olympic Track Meet.
5. Sacramento did not get the NCAA National Cross Championships for 2015-18, but may get future Regional meets.
6. Sacramento is likely to bid for the CIF State Cross Championships in 2016-18.
7. Reno Is bidding for 2015 Junior Olympic Cross Country Meet

Did you know:

- ✓ Over 50% of the Pacific Association (PA) membership registrations consist of Youth athletes (ages 4-18), team coaches, and parent volunteers.
- ✓ For the safety of PA athletes, Youth coaches and volunteers are required to be fingerprinted and background checked with the Department of Justice.
- ✓ The 2010 USATF National Junior Olympic Track & Field Championships, held in Sacramento, generated approximately \$45,000 of net proceeds for the PA.
- ✓ The Youth Committee averages \$9,000-10,000 net profit each year.

✓ During the 2013 Track & Field season:

- 10 non-championship track & field meets were held with an average of 500 participants per meet,
- 1,145 athletes participated in the PA Junior Olympic Track & Field Championships,
- 618 PA athletes participated in the Region 14 Junior Olympic Track & Field Championships, and
- 477 PA athletes qualified for the 2013 USATF National Junior Olympic Track & Field Championships in Greensboro, NC.

We plan to recruit more officials during the officials training at the start of 2014. Currently, we are waiting for certain paperwork to be completed before we can continue ahead and work more with the USOC.

LDR Ultrarunning (MUT) Sub-Committee

After Jon Olsen won the 24 hour World Championship he was training for the 100K World Championship. However, it was cancelled so he opted to go for the 100 mile American record. On September 28 at the Sri Chinmoy Self-Transcendence Annual Ultra Classic in Ottawa, he ran 402 laps on an indoor track in 11:59:28, breaking the 100-mile American record of 12:12:19 set by Rae Clark back in 1989. This also beat the 100-mile North American record, previously held by Canadian Andy Jones, who ran 12:05:43 on a road course in 1997. At this time I don't know if his run on an indoor track will be certified as a USATF record.

The PA Ultra Grand Prix has only the Quad Dipsea left to complete, out of 20 separate races at 16 events. We currently have 103 women and 195 men who have completed at least one race in the series. This includes 16 women and 49 men who have completed at least one 100 mile race. Several have completed 7 races, two have completed 8 and one, 49 year old Jean Pommier, has completed 10.

To get a feel for our PA Grand Prix compared to other Associations, the only other one we know of is the SCA which, on latest update, had total participation of 3 women and 24 men.

The officials' committee acknowledged the NCAA rule change for the pole vault collar mandatory for the 2013-2014 seasons as well as acknowledging the fact that it would be an NFHS rule starting the 2014-2015 season.

The following is information about the proposed training clinics which will be given by the Pacific Association/USATF Officials Committee in 2014. Some subtle changes may be made, but this information is firm enough for you to start making plans.

This is NOT an opportunity to "Sign-Up" for clinics yet. In early December you will receive a Google.doc for sign ups.

- We expect a clinic at ARC (**American River College**)...**Saturday, January 11th**.
- We expect a clinic at **Serra High in San Mateo, Saturday, February 9th**.
- Satellite meets will be held in Chico (**Saturday, January 25th Pleasant Valley H.S. Library**), Santa Cruz (**Saturday, February 8th**, Santa Cruz High) and in Reno (**Saturday, March 1st** at a site to be determined).
- *Rule Updates will be included in each class which is offered. 2014 is not a year for new rules.*

October 2, 2013 Meeting Minutes

College of San Mateo - Track & Field Stadium - Press Box

Present On Site: Fred Baer (Media), Tom Bernard (Men's LDR), Mark Winitz (Official, LDR), Christine Johnson (CTRN editor), John Rembao (Marketing)

Present Via Teleconference: Cynci Calvin (Communications), Maura Kent (Youth), Dave Shrock (President, Coaches)

Item #1 Is CTRN valuable to the Pacific Association?

Agreed among the attendees that pending improvements, *California Track & Running News* is a viable and valuable print publication for the Pacific Association.

Item #2: Ways to maximize the value of CTRN

- Cover as much less time sensitive material about the PA in CTRN, and for more time sensitive material, work with both the CTRN website and the PA's website to provide a compelling web presence.

- Christine Johnson said that CTRN is overdue for changes. She presented the following suggestions, which were met with approval from the subcommittee members.
 - Provide four larger print issues per year (currently there are five). The issues would be Feb., May, Aug., Nov.
 - Content of the print CTRNs would be divided into age categories: Youth, Open, Masters
 - Subject matter would connect more closely to each age category.
 - Content would not be time sensitive: profiles, stories, nutrition, coaching tips, photos, etc.
 - After these CTRNs are published and mailed, links to electronic versions would be posted at pausatf.org
 - Provide four “E-zines” – electronic magazines – that would be published in between the print issues.
 - These would immediately have links posted at pausatf.org.
 - Material can be more time sensitive: results, top performances
 - Can include multi-media, links to additional material, etc.
 - There will be no longer be a requirement for PA Road Grand Prix races to place ads in CTRN
 - Low rates will continue to be offered
 - For smaller PA Grand Prix events smaller ad sizes will also be an option.
 - Gathering appropriate material will be a challenge.
 - Volunteers are not reliable and very difficult to manage.
 - Ongoing outreach within the pausatf.org for material submissions is important.
 - Consider creating a Google Doc and Google Calendar on the new CTRN page for editorial submissions.

Item #3 - Specific Questions for Christine

- Re: What is the ad content vs. editorial content? Industry standard is 50% ads, vs. 50% editorial; CTRN is 30% ads, 70% editorial. Editorial includes cover, table of contents pages, photos (anything that is not an ad).
- Re: Can the Pacific Association receive an annual schedule of deadlines for ads and editorial material, for both quarterly print CTRNs and E-zines? Yes. Cynci also suggested adding a CTRN icon to the front page of pausatf.org that would link to all things CTRN.
- Can youth content be expanded? Youth content is very important since youth are such a large component of our Association. Christine agreed and hopes to accomplish this with the age-based categories described above.
- Item #4 - How can pausatf.org and caltrack.com websites become complimentary and synergistic for both editorial and ads?
- Pausatf.org tends to be a resource primarily for members with most of the traffic going to results, standings, etc.
- Film and photograph PA events and post on external websites, as Tom Bernard has done in 2012, 2013. Include links at pausatf.org and at caltrack.com. The logic is that these larger sites have huge traffic numbers so this builds exposure for our sites.
- Use social media to direct traffic to the two sites.
- Create links to material on other sites that have material pertinent to the PA (Flotrack.com, letsrun.com).
- Start to formulate a plan for ads. CTRN can offer packages to companies interested in placing ads on both sites.
- The pausatf.org renovation is building in ad space.

Action Items

From CTRN:

- Set up new publication schedule with quarterly print magazines and interim electronic magazines.
- Set up new layout for print issues, based on age categories.
- Provide the PA an advance schedule of deadlines for both ads and editorial
- Removal of PA Grand Prix Road Race ad requirement but continue outreaching to PA Grand Prix Road Race events with a range of discounted ad sizes and prices.

From PA/USATF:

- Create a CTRN page for pausatf.org. It be linked from an icon on the pausatf.org front page, have links to CTRN information (ad specs, deadlines, etc.), and a Google Doc and a Google Calendar for editorial submissions.
- Ongoing marketing/communications collaboration, especially as the new pausatf.org website goes live.
- Promotions for new events like the US National Outdoor T&F Championships (2014).
- Consider increasing a pausatf.org budget item for paid writers.

Association T&F Facility Inventory List Progress

Track and field facility surveys were mailed in June to all post secondary institutions located within the Pacific Association area. Exceptions were for those institutions where current information indicated minimal or nonexistent facilities for track and field. A follow up survey was sent in October to non responders to the June survey. To date, I have received responses from all 4 year post secondary institutions other than CSU Chico. With respect to community colleges, I have received responses from 12 and no responses from 8. My intent is to deliver surveys to T & F officials who reside near the 8 schools and ask them to fill out the survey as it can be 95% completed by just a visual inspection. In addition, an email follow-up will occur in an attempt to obtain a response. The state is divided into ten high school athletic "sections". Six of those sections exist in our association, which also includes several Reno high schools. There are 200+ high schools with all weather tracks. The survey will be slightly altered and either mailed or more than likely emailed, due to the high volume, to the sites in hopes of a response. I expect to complete the surveys from post secondary institutions by the end of the calendar year and ready for input into a designated area of the USATF Pacific Association website. Building a data base for high schools in our association area is more challenging and I expect to be collecting information through most of the spring of 2014.

Race Walk Committee Report

The Race Walking Committee finished its 2013 Grand Prix season with the final race, a 10K road race in Sacramento, on October 20. Grand Prix awards (engraved iced tea/smoothie/beer mugs) for the season were given three deep. In the team category, first place went to Sierra Race Walkers (33 points), second place to Marin Race Walkers (28 points), and third place to Pacific Racewalkers Organization (10 points). In the women's category, 1st place was Karen Stoyanowski (40 points, perfect score), 2nd place Susan Mears (33 points), and 3rd place Doris Cassels (28 points). In the men's category, 1st place was Alex Price (39 points), 2nd Joe Berendt (32 points), and 3rd Mark Green (29 points). In the age-graded athletes' category, 1st place was Doris Cassels (29

USATF Pacific Board of Athletics Complied Committee Reports: November 19, 2013 Meeting, page 10 points), 2nd Karen Stoyanowski (30 points), and 3rd Mark Green (29 points). Throughout the year, 26 athletes competed in the Grand Prix races.

The schedule for the 2014 season is coming together and will be posted on the PA/USATF website shortly after the national USATF convention. There will likely be one more Grand Prix race in 2014 than in 2013, with 1-mile, 1-hour postal, 3K, 5K, 10K, and 20K races in the coming year. In addition, several youth, all comers, and open track and field meets will feature race walks. The 2014 schedule will also include opportunities for training new Race Walk Judges and Race Walk Officials. If you would like to add one of those areas to your official's certification, come to the clinics at either American River College in Sacramento on Saturday, January 11, or Serra High School in San Mateo on Sunday, February 9. We need both judges (who judge the race-walking form) and officials (who help with such tasks as training lap scorers, recording information from the judges, and running the disqualification board to inform athletes that they may be out of form).
