## A Tale of Three Throws...by Dick Connors

At the 2010 USATF National Junior and Seniors Track and Field Championships, in Des Moines, Iowa, I worked as National Technical Official (NTO), basically observing the work of field officials as they conducted the various events. I witnessed great officiating in several events--and near disasters in two others.

One of my events on the first day of competition was the junior women's hammer trials and finals. This competition was as close to a disaster as I have ever witnessed at a national meet. The crew members were sent out to prepare the venue one hour before the competition but did not know what to do.

When the athletes arrived for warm-ups, the circle insert was missing, the count-down clock did not work, the benches for the athletes were out of place, there were no field distance markers along the sector lines, the field lynx measuring system was set up incorrectly because of the missing circle insert, and the spectator-restraining flags were out of place. The head of the event told me afterwards that he had never visited the venue before he brought the athletes out from the clerk check-in area.

Once the pre-event set-up difficulties were resolved, the competition got under way fifteen minutes late. With the first

competitive throw six officials all rushed to the spot and got in each others way; I expected to see bodies go flying. At the end of the first flight the event referee removed three of the six officials from the field by for safety reasons. The second flight was even later starting as there was no official available to go to the clerk's check-in area to pick up the athletes. The competition was a vicious embarrassing struggle for the crew, and ugly competition for the athletes with paying spectators left to fend for themselves.

The second day of competition in the hammer featured the men's trials and finals. The crew continued to have its problems. First, the paper work was misplaced. Second, the throwing implements arrived late. Finally, there was a shortage of volunteer retrievers to bring the hammers in from the field. With a great deal of struggle, the crew completed the competition.

The third day of the meet, I was assigned to the trials and finals of the women's javelin. And here I found an event run superbly. When I arrived at the venue an hour before the scheduled competition, the six officials were already going about their tasks of preparing for the competition, the field lynx system was being tested, measuring tapes were secured along both sides of the runway, the field markers along the sector lines were in place, the volunteers were being instructed, the athlete benches and water canister with cups were in place and the throwing implements had arrived at the head of the runway.

When a national record was achieved by one of the athletes, the steel measuring tape and record form were available to the crew immediately. The event was run with dispatch in a timely manner showing respect for the

athletes and the spectators. It was a pleasure for this observer to evaluate the work of this crew in action.

The third crew that I observed fell somewhere between the first two and exhibited a steep learning curve. On the first day of competition, I was assigned to the trials and finals of the men's shot put. The head of the event had worked diligently with the crew off the field before the competition, but when the crew was sent out to prepare the venue, they were leaderless and stood around waiting to be told what to do. Upon the arrival of the event head with the competitors for warm-ups the crew got moving; putting up safety flags, testing the count-down clock, moving bench and chairs into place. All the while the athletes wanted to know where to put their bags and when the sector would be open for warm-ups. The second day of competition in the shot the women had their trials and finals. An hour before the start of the competition, the crew hit the venue running. The venue was ready and waiting for the competitors and the officials were all seated in their appropriate places for the competition.

Self-initiative by the crew-members is not something to be left home when coming to a national championship.

Regardless of the size and scope of a competition, we officials must do our home work before coming to the field, and then be prepared to do any of the jobs that are involved in a competition and not wait to be told. All officials should bring their own tool bag and rule-books to the venue. Being prepared is very important at all levels of competition. Just because an official is selected to be head of event at the national championships does not make him or her the best official in the nation. The job takes preparation and work by all.

**Using Hy•Tek's Meet Manager** is **a four hour class** with an emphasis on:

- How to use Meet Manager software to organize and conduct high school dual/multi-team meets (complete results, scores and all) and
- Add to this a review of the changes with-in Meet Manager.v3.
- **If you bring your own laptop loaded with Meet Manager, this can enhance the learning experience—but it is not a prerequisite.**

**All About FieldLynx Operation...** *FieldLynx has been a Palm Pilot program to record and score field-events results; but now FieldLynx is moving to the laptop PC computer. Officials who want to work national meets are expected to know how to work FieldLynx. This is your chance to learn, and many of your local meets will offer you an opportunity to practice. All of the equipment you need will be supplied.*

**All About LaserLynx Operation...** *The Laser will measure your field events, but short of a national championship meet, it is the long throws which use LaserLynx for measurement. The Lynx is FieldLynx. The class will be a class and supervised use during the Stanford T&F Invitational. This is a two day class as you must learn set-up as well as use. **FieldLynx is a prerequisite.***

**Annual Rules Review...***Just what it says...this is a rules year for USATF and the NCAA. Both will have a new rule book this year.*

**Introduction to Clerking...***The CLERK is often an athlete's first contact with officials at the meet. Clerks are needed at all track and field, cross-country, and race walk events-- and most distance-running events as well. It is the CLERK'S job to organize the athletes into flights/heats, assure they have the correct hip numbers if those are required (and that the hip numbers are on the hip) and to get athletes-to the start line and into the proper lane. There are differences in the CLERKS job from All Comer meet to league, invitational or championship meets.*

**Introduction to Starting T&F Meets...***A classroom and practical clinic held in conjunction with the All Comer Meets at Davis, Los Gatos and U.C. Berkeley. After class you are expected to assist during the A/C meet. If you have equipment (pistol, ammo and loud speakers), bring your equipment. This class is appropriate for beginning officials and officials at the Association level.*

**Supervised Starting...***Supervised starting for officials who have some experience. The practice is available at the U. C. Davis and Los Gatos All Comer Meets. Bring your own equipment (gun, speakers, etc.) if you have it. You should have already attended the Beginning Starting class.*

**Introduction to Lap Counting...***This clinic will teach officials how to coordinate lap scoring for distance races on a track and for race walks. We will use the USATF Lap Scoring monograph prepared by George Kleeman in 2006 (and updated in 2010 to include additional lap scoring sheets and exercises). We will cover the official rules and principles of lap scoring, why good records of lap scoring are needed to certify records, the responsibilities of individual Lap Scorers, the Chief Lap Scorer, and the Special Lap Scorer, how to complete lap-scoring sheets (with blanks for 1.5-, 3-, 5-, and 10-K races), how to teach Lap Scorers to do their jobs, what to do when errors are made, and suggestions for handling lap scoring when shorthanded. We will practice the use of lap-scoring sheets for individual Lap Scorers and for the Chief Lap Scorer using examples for 3-kilometer and 5-kilometer races.*

**Implement Inspection (weights and measures)...***The role of the implement inspector is to weigh and measure every athlete's throwing implements to assure that they meet the specifications of the rule books. After inspection, the implements are collected (impounded) and the inspector is responsible for getting the inspected implements to the respective field event. In the event of a record...the implement is impounded and weighed and measured again. Implement inspectors are needed at every track and field meet that includes throwing events.*

**Introduction to Mentoring...***a class to ease the way for national and master-level officials to become mentors. It is one thing to want to be a new track and field official, it is another to know how to go about meeting the right people and getting invited to work a track meet. A mentor can ease the way of a new official and help assure they remain an official. National and master level officials are supposed to share their knowledge and experience and help younger officials in their associations.*
