Race Walking Committee

The Race Walking Committee of the Pacific Association has its schedule of Grand Prix races in 2015: (1) Onemile on January 24 in Berkeley, (2) One-hour on March 15 in Kentfield, (3) 5,000-meter on June 14 in San Mateo, (4) 3,000-meter on August 16 in South Lake Tahoe, (5) 10-kilometer on September 20 in Carmichael, and (6) 20-kilometer on October 25, also in Carmichael. The 20-kilometer race is also a USATF Western Region Championship. Grand Prix awards will be given at the end of the season to the top three places for women, men, age-graded individuals, and teams. In addition, race walks are scheduled at PA/USATF Youth meets on April 18, May 30, June 20, and June 27, and at the PA/USATF Masters Championship. Details of the schedule are updated on the PA/USATF website.

One set of Race Walking Officiating and Judging clinics was offered on January 10 in Sacramento, and another set will be offered on February 8 in San Mateo. The morning Introduction to Race Walking Officiating clinic covers the jobs of Recorder, Red Card Posting (DQ) Board Operator, and Head Lap Scorer (instructing volunteers how to record laps). The afternoon Introduction to Race Walking Judging clinic covers how to judge using the two style rules of race walking.

The most significant change in USATF rules for race walking is that road circuits of 2,500 meters are no longer allowed. Road courses are now limited to be no more than 2,000 meters and no less than 1,000 meters in length for races of 10 kilometers and longer. For road races less than 10 kilometers, the circuit is limited to at least 1,000 meters and nor more than 1,250 meters. IAAF is experimenting with a pit lane (similar to a penalty box) for youth meets; its implementation within USATF is unlikely, unless it is made a rule within IAAF.
