Informal Meeting

The informal part of the meeting was opened by Chairman John Murray at 10:10 am.

Informal Rules Discussion

To spark discussion, the Chair introduced **Sonny Maynard** to raise some situations that were challenging from a rules standpoint:

- High Jump competitor indicates he will jump, but shows up only when a few are left.
- Indoor shot put athlete claims error in measurement of another athletes preliminary throws, but long after prelims over.
- Collegiate pole vault, athlete demands warm-up an hour after completion begins.
- Master's combined events, 100 meters; one runner's blocks slip. What should have happened if a protest had been filed?
- High jump competitor also in hurdles, comes back when one jumper left. Does both jumpers get to select next height?
- Pole vault high school, no box collar padding is available. With 100 vaulters in competition, should officials allow competition?
- Boy's shot put with six attempt final, competitor has a running event, comes back when only one competitor left. Does he throw, and if so how many?

Byron Talley, interim head coach for UC Davis, welcomed the Officials to the campus. He will be moving to Dallas, and the head cross country coach will **Drew Wartenburg** will be taking over as head coach.

Irene Herman (on her birthday), President of PAUSATF, announced that PAUSATF was awarded a bronze award from the national association. She handed out a card about PAUSATF events for physically disabled athletes. The Central California Association USATF is having difficulties in carrying out responsibilities, so there is the possibility of the PA and the SoCal associations taking over geographic parts of the CC association.
