THE DICK CONNORS MERITORIOUS SERVICE AWARD

recognizes the 40 years of contributions by **Dick Connors** to the officials of the Pacific Association.

Dick brought all of his talents to bear within the association as Officials Chair, an active presenter at training clinics, as a Clerk of Course at innumerable track and cross country meets and as a starter.

Dick is in the NATIONAL OFFICIALS COMMITTEE HALL OF FAME, has received the NATIONAL OFFICIALS COMMITTEE ANDY ANDY BAKJIAN AWARD for outstanding service, the CHARLES RUTER AWARD as an outstanding running event official and an NOC CHAIR AWARD for services to the National Officials Committee. Dick was selected as a clerk at the 1996 OLYMPIC GAMES.

It is fitting that **George Kleeman** receives the first **DICK CONNORS MERITORIOUS SERVICE AWARD**, for George, like Dick, has been a driving force within the Pacific Association. As an engineer for Shell Oil, George was transferred from California to New York, to California, to Houston, then West Virginia and back to California in 1984. George settled in Martinez within the Pacific Association. Nationally, George has served as Vice-Chair for Rules and Training and chair of the



Equipment and Facilities Specifications Committee for the National Official's Committee. He has served as the Vice Chair of the National Rules Committee and is an ITO (International Technical Official) who worked (among other assignments) as an ITO at the Beijing Olympic Games. Within our association George (a Master Level official with multiple certifications) is one of the go-to-guys on questions about rules and has served on the Pacific Association's Board of Athletics as its treasurer,

THE DICK BARBOUR - SPECIAL RECOGNITION AWARD – FIELD

*THE DICK BARBOUR SPECIAL RECOGNITION AWARD – FIELD honors the contributions of **Dick Barbour** a Master Level horizontal jump official who was selected to work the 1984 Olympic Games in Los Angeles.*

In the early days when track and field became its own NGB (National Governing Body) separate from the AAU, Dick was the first treasurer for the Pacific Association Board of Athletics.



It is fitting that **Bruce Makinson** is recognized for his work as a field event official with **THE DICK BARBOUR -SPECIAL RECOGNITION AWARD – FIELD** for Bruce is in the mold of Dick Barbour, a Master Level official who works every field event except pole vault. He does some starting, too. Bruce has officiated at every college and university facility between Ashland, Oregon, and Cal State Stanislaus. Career-wise, he taught ninth grade social and health sciences for 32 years, coached at Shasta High School in Redding from 1974 to 2005, and was recognized in 2011 for his work with his selection to receive a NATIONAL OFFICIALS AWARD certificate. Bruce was the crew chief on a medevac helicopter in Vietnam in 1965 and 1966.

THE HORACE CROW - SPECIAL Recognition AWARD – FIELD

THE HORACE CROW SPECIAL RECOGNITION AWARD – FIELD honors the contributions that



Horace Crow made to the Pacific Association and the health of track and field nationally. Within the Pacific Association, Horace was a Master Level official who usually ran the pole vault.

On the national level, there are two yearly awards named after Horace, a National Officials Committee Award for an outstanding field event official and an award from the Associations Committee, which acknowledges his contributions to that committee.

The Pacific Association Officials Committee recognizes **Bob Thompson** with THE HORACE CROW - SPECIAL RECOGNITION AWARD – FIELD for his work in the throws and his work as an instructor and mentor for young officials. Bob became a certified official in September of 1993 and achieved Master Level in the Throws in January of 2009. Bob was heavily influenced and mentored by **Dick and Shirley Connors, Bill Edgar, Sonny and Lori Maynard, Phil Watkins,**



and **George Kleeman**. Bob reports that his favorite sandwich is meatloaf, although he doesn't suggest whose influence that reflects. In 2007, Bob's work was recognized

with a NATIONAL OFFICIALS AWARD certificate.

Unfortunately, Bob had a conflicting family obligation and was not present to receive his recognition personally. □

THE GEORGE NEWLON SPECIAL Recognition AWARD – TRACK

THE GEORGE NEWLON SPECIAL RECOGNITION AWARD – TRACK honors the contributions of **George Newlon**. In the days before fully automatic timing, George Newlon was the master of the finish line and its hordes of hand timers. As track and field became independent of the AAU, George found himself the leader of what would become the Board of Athletics. In the days before fully automated finish lines, George Newlon was our leader.

With this in mind, the Officials' Committee is honored to recognize the work of **Joe Nemeth**, a Master Level official who specializes in the weighing and measuring of throwing implements, with THE GEORGE NEWLON SPECIAL RECOGNITION AWARD – TRACK. Joe has a truckload of gauges and scales to assure that all throwers have a fair shake. Joe arrives early, works in isolation and attends all levels of meets around the Pacific Association.



For those who are “friends” with Joe on Facebook, he often makes baseball references. It turns out that before then Hartnell Head Track Coach Gary Shaw recruited Joe to track and field, Joe was an athletic trainer. “I spent six years with the Texas Rangers minor league clubs. I spent one year in Wausau, WI (1979) (Wausau Timbers), one year in Asheville, North Carolina (1980) (Asheville Tourists) 3 years with the Tulsa Drillers

(1981-1983) and my final year in Burlington Iowa (1984) (Burlington Rangers). I was an athletic trainer. In 1982 Tulsa won the Texas League Championship. This is my connection to the baseball world. Gary Shaw (retired) got me involved with track and field with inspection of implements 22 years ago at Hartnell College for the Ed Adams Invitational. I have been doing many other colleges and other championships these 22 years. □

THE LORI MAYNARD - SPECIAL Recognition AWARD

THE LORI MAYNARD - SPECIAL RECOGNITION AWARD honors the contributions Lori made to the Pacific Association as a leader, an official and a race walker. Lori served as THE HEAD HAMMER THROW OFFICIAL IN THE 1996 Olympic games in Atlanta and as an international race walk judge in the 2000 Olympic Games in Sydney. She was also a member of many national TAC and USATF committees. The Lori Maynard award recognizes extraordinary contributions which do not fall within the realm of our other awards.

Bob Rush epitomizes service to both the track and field and the cross country families within the Pacific Association. Bob has often represented the Pacific Association at the USATF National Convention. He designed the CSM

Crystal Springs Cross Country Course in San Mateo and invented/developed the Chronomix Timing Machine, which was a mainstay of timing cross country and road runs up to the time finish lines became automated. Bob was instrumental in introducing computerized on-line registration for meets to the California Community Colleges. Bob at age 81 continues to work as an announcer, meet organizer, cross country timer and runs a few miles on the CSM Crystal Springs Course on a regular basis. He does this to say hello to the local rattlesnakes which he knows on a first name basis. □

Magley previously served 10 years as an assistant with the Hornets where he oversaw the team's throwers.

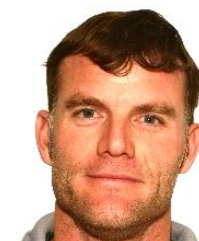
"We conducted a national search to replace Coach Raske and, at the end of the process, we felt the best fit for our program

was already on staff," Macriss said. "Coach Magley has been a member of a very successful program for a decade, and he made it clear during the interview process that he understands what it will take to keep the program competing at a very high level in the years to come.

Harmon recently completed her first season at Sacramento State. During the fall, she coached the Hornet cross country program and saw dominant individual performances from Chloe Berlioux. Along with leading the cross country team, she will serve as an assistant during the track and field season coaching the distance runners.

Harmon came to Sacramento State from TCU where she was the Horned Frogs' head cross country coach in 2014. She also coached at Oregon State from 2011-14. As a student-athlete, she earned All-America honors in cross country while competing at Oregon and also competed at the NCAA Div. I Indoor Championships in the 5K.

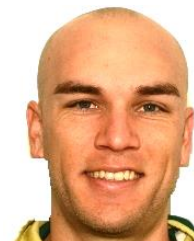

MISSING FROM THE TRACK

DAVIS, Calif. - In late January, **Jon Vochatzer** suffered a stroke shortly before he and his wife, former women's track coach Deanne Vochatzer, were to depart for an annual trip to Pismo Beach. He subsequently battled for two weeks before entering hospice on Wednesday, February 10. He died on Monday, February 22, at the age of 71.

Jon was a standout football and track athlete at Amos Alonzo Stagg High School, San Joaquin Delta College, and Cal State Hayward; Jon Vochatzer joined the UC Davis athletics staff in 1979 after successful coaching stints both in the U.S. and in Germany. He became an assistant football coach under Jim Sochor and took over the men's track & field reins from **John Pappa**, who remained on his staff as an assistant until 1992.

In his career at the track helm, Vochatzer earned 11 conference Coach of the Year awards plus 12 West Region Outdoor Coach of the Year awards, six in the indoor season, six in the outdoor season. Eight Aggie men won NCAA individual championships during his tenure, headlining a list of 76 All-America awards bestowed upon the program in the Vochatzer era. His teams placed among the top five at either the NCAA Division II indoor or outdoor championships four times shortly before the university made a transition to Division I.

On the national and international scene, Vochatzer represented the university with appointments to the coaching staffs at the 1995 U.S. Olympic Festival, 1997 World University Games and 1999 IAAF World Championships. He also lent his expertise to the 1996 U.S. Olympic Team -- for which Deanne served as head women's coach -- while serving as competition manager at the 2000 U.S. Olympic Team Trials.

Jon and Deanne Vochatzer jointly ran the two track & field teams throughout the 1990s and 2000s, although department listings officially distinguished them as the men's and women's head coaches, respectively. Appropriately, both Vochatzers entered the Cal Aggie Athletics Hall of Fame as a husband-and-wife tandem in 2013; each enshrined for their respective individual accomplishments.

After retiring from coaching, Jon became a certified official and developed into a sought after track referee.

Jon is survived by his wife Deanne, sons Chris and Scott, grandson Jonathan and granddaughter Addison, mother Mary, and brothers Gary and Charlie. □

Richard Cabral, master clerk 1937 - 2015 - By Dan Davidson

Track and field lost a truly nice man on December 18 when **Richard Cabral** succumbed to colon cancer.



Rich was a husband of 57 years, an official for over 25 years and an outspoken advocate for abused children and women. While in their early years of marriage, Mary and Rich gained custody of several young cousins and nieces. They did not receive any compensation for the guardianship, but Rich had contacts with social welfare. Looking into a way to gain financial assistance for the benefit of the kids, Rich was aghast to find that nothing was available unless you were a foster

parent. Eventually, with input from social workers, legislation was passed creating the California- and federally-funded **KinGap** program that provides monetary relief for adult relatives who have custody of minors for over a year, then continue to have custody. Grandmothers, especially, gained from this service because of the gains in medical and social services for the children in their charge.

Rich first came into track officiating while living in Modesto, which is where I first met him. He had started clerking as a volunteer. Impressed by the good job he was doing, I convinced him to become certified. He and Mary, his wife, moved from Modesto to Elk Grove, and he became certified in 1990, then gained Master Level in '99. He did try other officiating duties, but his love was clerking, which he did in many meets, including the Modesto Relays, the Stanford Invitational, many major youth meets and of course many meets around the Bay Area and the San Joaquin Section for both high school and college meets. In 2006 Richard was honored with the PA's **The George Newlon Special Recognition Award – Track** in 2006.

I recall a specific incident at San Francisco State, where I showed up to clerk, with him as my assistant. He was sort of grumpy that day. When asked why, he responded that clerking for meets in San Francisco, Stanford, etc. was costing him \$500 or more each time. It seems that Mary enjoyed shopping, so while Rich clerked, she shopped. I jokingly told him to get her involved in clerking, too, by telling her she is so well organized and so good with young people. Well, he did, and eventually Mary became a clerk, gaining certification in 1999. He even got his granddaughter, Morgan, involved as she was certified in 2002 at the tender age of 15.

Rich worked for the state for 35 years as a peace officer, retired for about five years, became antsy, and then worked for Sacramento County Social Services for ten years. Sad to say, Rich developed colon cancer about four years ago, received treatment and recovered but was never really in good health after that. He ended up with pneumonia several times, and eventually passed away December 18.

We send Mary our condolences and will miss Rich. □

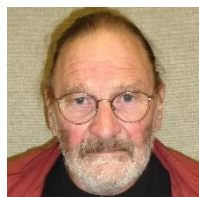



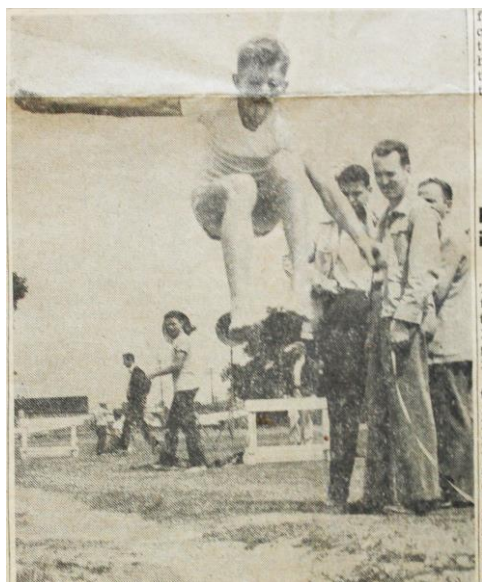
