# This was/is my fifth ReCert and the most difficult by far:

- New ReCert Rule Reviews were not ready in time and have been consistently dribbled out;
  - a. New ReCert Rule Reviews had not been field tested before publication leading to multiple versions
- There is that SafeSport requirement and not all of USATF's files are accurate
- Some officials bought a "new" USATF membership instead of ReNewing...leaving some files with their former USATF # and some with their new USATF #.
- 4) The requirement for an NCSI background check has caused some people to quit/go Emeritus (although all Emeritus are not NCSI related).
  - a. Side note: John Miller at NCSI has been really helpful in assisting/answering questions.
    - i. NCSI gathers the information, BUT it's USATF which makes the determination.
    - ii. I've only seen one Fail and it was from several years ago.
    - iii. EVERY newbie and everyone who signed up for a ReCert clinic knew in advance of the NCSI requirement, which I mention given the number of people who attended a newbie or ReCert clinic and haven't followed thru on the NCSI thingy.
    - iv. Only one possible Newbie said, "Forget it!" after finding out the four hurdles he would have to climb (USATF #, NCSI, SafeSport, class).
- 5) There does not seem to be any one person at USATF we can go to for help and sometimes we get contradictory information for various people.
  - a. There does not even seem to be a go-to-person for a particular problem...USATF membership, NCSI background check or SafeSport.
- 6) For a while CertChairs had access to the NOC (National Officials Committee) official's database, and then we didn't
  - a. I'm not sure I would have made a good CIA analysist, but by gleaning what hints available, I believe that USATF is rewriting the code and will place the NOC official's database on their servers and under their control, but I don't know when this will happen.
  - b. Depending on how much a ReWorked database will allow CertChair to do themselves, when the new ID cards will be printed/distributed is a mystery. [For the Pacific Association, Roger Burbage, the National

CertChair, would have to make at least 56 additions/corrections before he could print out cards, and he has 57 associations.

c. Examples: For the first three ReCerts I did, a CertChair had a screen full of check boxes to check/uncheck for certifications one wanted. For the last two ReCerts, some UpGrades were available and some were not. (Enter discussion on how Db has worked since 2012.)

### About ReCert Clinics:

- 2) About books for sale:
  - a. I ordered 110 2017-2018 NCAA Rule Books; we sold 109.
  - b. I ordered 100 2017 NFHS Rule Books; we sold 94.
  - Ajay collecting the \$\$ went well (88 NCAA books and 74 NFHS books ordered)
  - d. Ajay gave me an Excel file of books ordered, I used that file, printed labels with for each order (name, clinic they said they were attending, # NCAA books ordered, # NFHS books ordered), wrapped each order and went to each clinic with the ordered books.
  - e. Book delivery went as planned ... mostly.
  - f. I will recommend to whoever does the 2020 ReCert that they order and deliver books as listed above. Maybe even order a few more books with the intent of selling at any/all clinics.
    - I would recommend that NO rule books be supplied for the ReCert clinics, but, the year before ReCert remind everyone to get the books they will need or be prepared to go on-line to look at the book.
- 3) About Google.doc registration for classes
  - a. I should have/would again, split the "What clinic site will you attend?" question from the "What class will you attend?" question.
  - b. Most people signed up for the Serra ReCert T&F (site) even when they were LDR and/or RW officials.
  - c. People signed up for clinic, sometimes multiple times, and didn't show up.
  - d. People showed up without signing up for the/any ReCert clinic.

- 4) About the ReCert clinics themselves:
  - a. The primary use for the satellite ReCert clinics at Hartnell JC/Salinas, Merritt JC/Oakland, and Pleasant Valley High/Chico, was to bleed people from the ARC and Serra clinics.
  - b. The primary use for the satellite ReCert clinics in Reno was to eliminate travel for a hand full of officials from that area.
    - i. If it wasn't for the Prices/Bowens handling the clinic, going to Reno would not be worth the time/energy/expense.
  - c. My original plan for the ReCert class work was pure genius, it just didn't work very well. My redesign I believe worked better.
    - i. If we had had the ReCert reviews earlier I'd like to think we would have had a December ReCert and field tested the classwork portion before ARC.
    - ii. I set Bruce Makinson up for failure at ARC and succeeded...much to my chagrin.
    - iii. The first priority in a ReCert class should be going over the *"homework questions"*.

## Added thoughts:

- ✓ I am carrying several officials as "On Sabbatical" for they are having health or family problems: Bob Shor (health), Cherie Sherrard (health); Bob Dietrich (family – Reno area referee)
- ✓ An unconsciousable number of officials are eager to work a national level meet but never buy a rule book ⊗
- ✓ Many people are "certified" as referees but never work as referees. A number of Youth officials work as referees but are not "certified" as referees. I'm working on getting them to at least take the Referee Rules Review.
- ✓ I am planning/trying to pawn off the UpGrade/or not problem for starters to a group of Master Level starters.
- ✓ We have a number of new officials from the Stockton Saints, most of whom showed up without registering for class and about half of whom took their SafeSport "on-line" but don't have their NCSI. We did get several new Youth racewalk officials trained.
- ✓ Thanks to John Murray, we were successful in getting 34 officials selected to work the outdoor meet.
