Races: **20K** USATF Western Region and Pacific Association Grand Prix Championships
5K non-championship race
2K (for kids ≤ 14 y/o)

Time: **8 AM** (Packet pickup and race-day registration from 7:00 – 7:45 AM)

Place: **William Pond Recreation Area, Sacramento, CA**

Directions: From Highway 50, take the Watt Ave North exit. After about 1.1 miles turn right onto Fair Oaks Blvd. After about 2.4 miles, turn right on Arden Way, which ends at the park. Turn right, pay entry fee at the kiosk, and proceed to the last parking lot.

Volunteers: We need your friends/family to help, without which the race will not occur.

Awards: **20K: Western Region Championship Medals**
for the top 3, male & female **in 5-year age groups**
20K Pacific Association Medals for the top three, male & female.
2K and 5K: Medals with ribbons for top three male and female in each race
2K winners will receive awards after last youth has finished.

Eligibility: All racewalkers of any age. Awards only to USATF members.

Entry fee: **\$45** for adults, **\$10 for kids**) postmarked by September 18.
\$50 (\$15 for kids) on race day.
