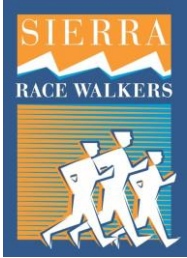

Date: Sunday, October 7th, 2018
Time: About 10:30am, AFTER the Men's and Women's 10 Km Racewalk
Course: Three laps on a certified 1 kilometer loop within William B. Pond Park in Sacramento, CA.
Directions: Take the Watt Ave N exit off of US 50 and proceed about 1.1 miles north to Fair Oaks Blvd and turn right, proceed on Fair Oaks Blvd about 2.4 miles then turn right on Arden Way. In about 1/2 mile Arden Way enters the Park. There is a \$5 County park entrance fee (or you can park outside and walk in).
Entry Fee: Pre-registration \$20 **Postmarked by Oct 1st**, or Race Day \$25. Please make checks payable to Sierra Racewalkers and mail to: Sierra Racewalkers, 7073 Enright Dr., Citrus Heights, CA 95621
Eligibility: Event is open to all walkers of any age. This event is conducted under the rules of the **United States Power Walking Association**.
Post Race: Potluck picnic in the Park, Awards and Annual PA meeting. Lunch is \$5 (for athletes and guests) OR bring a salad, side, or dessert to share. Deli sandwiches and fixings will be provided.
Awards: Prizes will be awarded for the first three Male and Female Power Walkers
