- VII. Rule Changes (Bob Podkaminer, John Shirey)
 - A. 2018 is a Rules year for NCAA. Next rulebook is due Nov. 1 for 2019 2020.
 - B. Rule changes are posted on NCAA website.
 - 1. Time rules for Field Events (30 seconds) except Pole Vault. Don't know whether time changes apply to Combined Events.
 - 2. Some uniform rules changes but don't know details. Penalty for noncompliance?



- 3. Starters: As of this year, starters may use the electronic starting system for recalls, whether a false start exists. Currently only used at D1 championships.
- 4. At D1 National Championships, electronic start will be used. It will be available at other levels. This system will also be used at USATF.
- 5. Relay zones: 4x1 & 4x2 fly zone is now part of the relay zone. Cannot start outside of the zone. Don't change starting point, marking, etc.
- C. This is also a Rules year for USATF.
- VIII. Dave Shrock Presentation
 - A. \$3693 contributed to the USATF Pacific Foundation as George's remembrance fund. To be used for officials' training.
 - B. Several large meets in our Association this year. Nationally, officials membership is down. We will need officials for JO's, etc.
 - C. SafeSport- Concern about our volunteers and whether they are cleared. Trying to get 1 time waiver so we don't eliminate our volunteer pool. Officials are Mandatory Reporters at events. Report incidents to Meet Referee. Concerns were raised about having Best Practices procedure for all to follow when reporting an incident.
 - D. Moving toward getting all coaches badged, especially in Youth. Hope to begin in 2019. From 2019 onward, coaches must demonstrate an education component. Goal is to increase professionalism of coaches.

At the end of July every year, NOC does a headcount of the number of certified officials by association.

- 1^{st} How many additional votes will an association get in NOC at the convention;
- 2nd How many National Certificates are they entitled to @ 1 per 100 certified officials

PA/USATF has the most certified officials with 278 to Southwest's 249, and I agree with the national account.

20 of 57 associations have > 100

34 associations have < 100 with 15 < 50.

CA has lots of people: Central = 13, SD/Imperial = 64, SoCal = 147 with PA 278.

Some officials trying to work the Pole Vault Summit in Reno have found that their names are not showing their SafeSport and/or NCSI Background clearances on the USATF database.

Ask me, for I can get you proofs you can e-mail.



Starting the first week of November:

✓ 123 officials need to ReNew their USATF membership

Many officials have an ID badge which says their membership expired at the end of 2016 or 2017. USATF was supposed to issue a new ID badge with your ReNewal of USATF membership. They didn't, and I didn't have the means to track 'em.

Now I have the means to track 'em and, after you ReNew, get you an UpDated badge.

✓ As of Jan 1.2019, if you have not ReNewed, you are no longer certified ⊗ for the USATF computer is good about things like that.

The same goes for your NCSI Background Check. It's been two years since your ReCert/Certification, and your NCSI lasts for two years.

✓ 68 need ReNewal of NCSI in Nov or Dec

✓ 130 need ReNewal of NCSI in Jan, Feb, or Mar.

I am told you will receive an e-mail from NCSI warning you in advance of your need to ReNew. *Pay Attention* ⁽²⁾ I believe you will need to ReEnter your ID (picture of driver's license or passport).

24 officials still have not asked for their USATF National Navy-Blue Polo Shirt – in spite of copious requests.

Our New for '19 list has 16 names already with 8 more as 2nd chancers who asked about becoming an official in 2018 but did not follow through. After the 2nd year of "No Show," I drop 'em.



- ✓ If any officials did not receive the new USATF Official's pin previously, Ajay has a supply. You are entitled on only one, so if you already received one, that's it for this Olympiad.
- And finally, I'd like to introduce you to the heir-apparent as your new CertChair; Ajay Pad gaon kar. Between now and the end of the 2020 ReCert, Ajay and I will work together as he learns the job, and at the Annual Meeting in 2020 Ajay will inherit the job, hat and all.
