 - e. Dave Soeth & Dave Shrock are interested in putting on Intro Clinic in Stanislaus area. Want minimum 5 10 attendees.
 - f. Hartnell (Chris Zapeda) is interested in hosting a clinic. Bill suggested they get in touch with Monterey Peninsula College and get enough High School coaches to sign up.
 - g. Hume: Do we want to train people to become officials if they don't get certified? 3 point certification: Background check (NCSI), Safe Sport, Certification.
 - Consensus is we want to train people who will become certified, not just get trained.
 - ii. Would be great to have computers at clinics so people could pay membership, pay for background check, etc.

- 1. Numbers game.

- 3. New website will not allow USATF to do multiple years of signup. Signup now for multiple years.
- 4. 35 need NCSI checks in 2019; 139 in 2020
- 5. Recertification is up in the air. There are two camps: the test should be as stiff as possible; or, the test should only be a review.
- 6. All (203 in PAUSATF) need to do SafeSport by March to remain active.
- 7. 29 PAUSATF officials applied to work National meets in 2020.

VI. New Business

- A. PAUSATF Foundation, Officials Training Funds (John S.)
 - We have received the Kleeman bequest. There are no conditions attached to expenditure of that money. Foundation board needs to know if there will be a request to pay fees to rent facilities for Training Clinics.
 - 2. We raised \$1774 at the Officials Annual Meeting.
 - 3. We have access to Pacific Association's email list with 20,000 names. Our first mailing did not get much response. Those who did respond are officials.
- B. Officials Stipends/Donations to PAUSATF (Joe Van Zant, Mike Bower)
 - A handout of the pay structure based on So Cal Association's policies was reviewed.
 - 2. A handout on existing guidelines (from John Murray & George Kleeman) for supporting officials was reviewed.
 - 3. A draft survey of officials regarding pay was reviewed.
 - Jim Manha: If Stanford is required to pay individual officials, they will reduce the number of officials used for their meets. (Lilygren: This is what happened at UCLA when So Cal required paying officials.)
 - Van Zant: Some officials have asked me to ask about pay now that I am on the Executive Committee, so I am.
 - Murphy: Officials are going to work the meets they want to work, regardless, so I'd rather not rock the boat.
 - Hume: Suggest we put this conversation on the back burner until we get more information about what is being done in other associations.
 - Manha: Has offering pay increased the number of officials willing to work?
 - Van Zant: American River got more.
 - Bower: At Cal, the numbers did not increase significantly.
 - Murphy: You don't get paid to go to Chico, but they treat you right.
 - Bower: We can't cover our large area in the way it needs to be covered.
 - Motion to table pay discussion approved.
 - Leake: We can still send out the existing guidelines again. I need to send Stanford their bill for this year.
- C. Officials Recruitment/Marketing. (Phil)
 - Leake: The officials recruitment brochure has not been updated in at least 10 years
 - 2. Others: How do we retain parents as officials after their kids graduate?
 - The Association has a presence on Facebook.
 - 3. Do Community Colleges still have officiating classes?
 - ARC cancelled theirs due to low enrollment.
 - CSM doesn't have officiating classes.
 - 4. Shirey: How do we market the enjoyment we get from track & field and capture that interest? We shouldn't get hung up on age groups; we need more officials, period. Age of officials is an age-old problem. (Lilygren: Years ago at an Annual Meeting, I was talking with the coach at William and Mary.



He said he made his athletes join the Officials Association so that they would learn the rules. Some of them actually became officials after graduation. We might talk with the local coaches and gauge interest with their athletes.)

- 5. Marketing Services are expensive.
 - Van Zant: Do we have someone in our association with this expertise?
 - Heberle: The association Marketing Chair position is currently vacant.
- D. Officials Election Date Changes. (Phil)
 - 1. Heberle: Procedures for committee elections are given in the Association Bylaws. So, each committee's operating procedures do not need much detail beyond the list of elected officers.
- E. Amending Election Operating procedures to Coincide with General PAUSATF Officer Elections.
- F. USATF Annual Meeting
 - 1. Hume: We get 3 votes in the Officials Committee.
- G. Stanford Officials and Meets/Sonny Maynard's new role (Jim M.)
- H. Next meeting: Sunday, March 8, 2020, 1 PM, at Charles Murphy's house. (Take note of the beginning of daylight saving time.)
