### Chairs Report

Within Membership, Mike Aro will be retiring with the completion of the 2022 Season. Thank you Mike Aro for all of your years of service and participation! We will miss you around the Oval.

Throughout the season and the conference finals several of PAUSATF Officials were selected to the Conference Finals for State CIF, NCAA Big West Conference Championships, Mountain West Conference Championships , and Pac12 Conference Championships. - 1. Certification Chair Report (Ajay)
  - a) As of March 20 certified officials count is 235. Since November 1, 2020, 130 new officials were added in; two transferred from outside Bob Hooper from Arizona and Kelly Brown from Central California.
  - b) All the badges for those newly certified or recertified have been sent out. Some officials reporting misplaced badges had to ask national office to reprint them. National Office has been quite slow in all responses since Luke Fimrite left.

There were some issues with USATF Membership renewals due at the end of the year but are all now resolved. NCSI is once every other year very few issues. # MENTORING REPORT TO Pacific Association USATF Officials Executive Committee June 12, 2022

Presently, the Mentor Chair has been conducting meetings with the six Regional Resource Coordinators with the Certification Chair and Training Chair. The last meeting held on April 4, 2022.

At that meeting, it was decided that the work of the ad hoc Committee on Enhancing Pacific Association Communications was completed and therefore the Committee was dissolved. From the ad hoc Committee, Robert Benoy is remaining as an ex-officio member. It was felt that the Regional Resource Program was ready to begin performing its responsibilities.

At the April 4<sup>th</sup> meeting, a brief training was conducted by Ajay Padgoankar on the requirements for upgrading certification levels for the Coordinators. Since that time, the Coordinators have been contacting their officials about upgrading procedures.

Also, since that last meeting, there has been a change in two of our Coordinator positions. Dennis Boyle has replaced Anthony Davis who has found it difficult to fulfill the time requirements needed for the position and Ryan Cowley has replaced Mike Aro, who is retiring from officiating. Also, Ryan's region has been renamed from SouthBay2LA to SouthBay-South.
