Maria Costello:



Maria joined the track and field world in 1995 where she started working the finish line at a 3M's Club track meet. In 2005 Maria joined the USATF team as an official and later became the youth official chair, a position which Maria held for two years. In 2007 Maria became the youth vice chair of the Pacific Association teaming up with Chair Joanne Camargo. As vice chair Maria worked tirelessly on many youth champion meets as co-meet director, and in 2010 she facilitated the award ceremony at the Junior Olympic National Championships held in Sacramento. Maria is retiring from an official role in the Youth Committee this year

Dan Davidson:



I have been officiating since 1962, became active in the Association in the early '90's. As Awards Chair I brought organization and was adamant about involving as many members as possible in the nomination/selection process.

I have officiated in many different assignments and in many local and national championships, including the National JO's on four different occasions; , the NCAA Championships; the World Masters' Championships, one in Oregon and one in Sacramento; two Olympic Trials; and of course many Special Olympic meets, Age Group, High School, Community College, and Collegiate league championships, state meets, and Invitation meets.

I worked at all aspects of officiating, starting with the Javelin, in the early '60's, and officiated at all the field events; I clerked at many national championship meets, headed the finish line many times, and currently am running the Lynx Timing for many local and Nor-Cal schools. I have also been fortunate enough to have been selected into two Halls of Fame: Eppie's Great Race; and the C.K. McClatchy Hall of Fame, for the two consecutive Section/undefeated cross-country teams in '58 and '59. I also held the County Record in the 880, and held a school record in one event or another in every school where I participated.

I started my coaching career while still in college, and continued doing so until 2001 – forty (40) years. Every team/school where I coached eventually won league championships. I was fortunate enough to have athletes buy in to my method of individual and team performance. I coached little league baseball, basketball (both girls and boys), cross-country and track and field. All this while teaching English and Journalism, mostly, and also doing 'my own thing' and running many road races of varying distances.

I started the girl's track and field and cross-country programs at Foothill High School of Sacramento in the mid-70's, eventually winning many league and subsection championships and one Section Championship in 1980. Other accomplishments for which I am proud: establishing a five city continuation school basketball league; creating and developing an At Risk Jr. Hi Program that became one of the best in the school district.

I have been active for many years in the Pacific Association and do not regret any of them. It's been a wonderful career.

Ken Grace :



Ken Grace is being acknowledged for his continued service to our sports by assisting in providing facilities for meets, clinics and coaching education schools at Chabot for over a decade. Grace has coached track and field and cross country both community college and high school for 30 years. USATF certified level 1 & level 2 in both jumps and endurance, Coach Grace has six community college state T&F champions, one high school state champion in cross country, and one national JC champion to his credit. Grace has authored several articles on training and endurance. Coach Grace has served in both the head XC-T&F coach and dean and athletic director at Chabot, and was awarded the California Community College Coach of the Year Award in 1991. Grace has earned his BS in Kinesiology from Cal-State Hayward, and MA in Education from Stanford University.

Phil Watkins



Phil started officiating in 1964 when I timed races at the Cal Aggie Picnic Day meet and timed a runner who broke a record for the 880 which I held for ten years. Dan Davidson and I met at Sacramento City College in 1960 where we were both running the 880. I was an old man by then as I had served 5 years in the Air Force prior to that. Dan and I worked many meets over the years mostly hand timing. He started doing Accutrack while at Sac State and by then I was working mostly field events and still hand timing. I soon noticed that Dan got to see all the running races while I seldom saw any of the races while busy with field events. I then asked Dan if I could work with him and the Accutrack and started a long history of the two of us doing FAT timing. We both continued to work other events and Dan did a lot of clerking and I was doing lots of weights and measures.

Besides track we were also doing cross country. We were part of the group doing the score keeping for the San Joaquin Sub Section and Section T&F Champs. for a number of years and along with Dick Iwamiya decided it was really taking too long and too much work. We then went to the Section meeting and offered to do the meets by computer. They took us up on the idea and we then went to Bob Rush and learned how it could be done. That started our group, 'About Timing Assoc.' and started us on our way to the Lynx timing and left Accutrack behind. There were four of us to start, the fourth being Bill Edgers who died several years ago.

We have been doing meet for small schools and leagues meets from Orland to the north and Patterson to the south, along with the Bay Area and Marin and up to Frog Town and many places in between.
