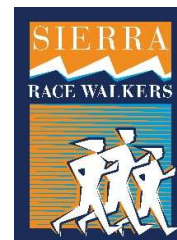




USA Pacific Association 10K Racewalk Championship with Other Races



Date: Sunday, October 25th, 2026
Time: 9:00AM Combined Men's and Women's Race Walks, followed by Power Walks
Location: Certified* 1 km loop within William B. Pond Park in Fair Oaks, CA, near Fair Oaks Blvd and Arden Way. Requires \$6 County Park entrance fee (or park outside and walk in).
Entry Fee: **Racewalk:** \$35 if Postmarked by **Oct 20**; or Race Day \$45
Power Walk: \$20 if Postmarked by **Oct 20**; or Race Day \$25

Eligibility: Only Pacific Association members are eligible for Championship Awards. Athletes may enter racewalk and power walk, using separate forms.
Post Race: Awards follow the races, also Annual Racewalk Committee meeting.
Awards: Pacific Association RW medals for the top three Female and Male Race Walkers in each racewalk. Special prizes for top three 3 power walkers. Races not eligible for USATF records. Finishers at longer distances are eligible for awards at shorter distances.
